LETTER FROM THE CO

Dear Resolute friends and family,

Greetings from south of the border! Team *Resolute* is heading home after spending 60 days down-range in support of Operation Vigilant Sentry (OVS). We patrolled the Windward Passage, Mona Passage, Old Bahama Channel, and Florida Straits, defending our maritime border and southern approaches. Some days we operated as part of a multi-ship task unit covering multiple smuggling vectors, while other days we sailed alone and unafraid as the only Coast Guard asset in the area. Through it all, the crew continually impressed me with their professionalism, enthusiasm, and work ethic while doing a tough mission in a challenging maritime environment.

We spent most of January and February working in the Windward Passage off the coast of Haiti. As part of our OVS support, we served as commander of a task unit composed of other medium-endurance cutters and fast-response cutters. Our mission was to provide "overt presence" that would deter illegal alien smuggling ventures from Haiti towards the United States. This involved spending lots of time close to shore, transiting the Canal de la Tortue, Port de Paix, Cap du Mole, and Cap Haïtien, and using an embarked Creole translator to help us meet with locals to discuss in-country conditions. Due to the dire social, political, and economic conditions in Haiti, there is a strong "push factor" that drives migration and smuggling into the northern Caribbean and towards the United States. When the cutter *Escanaba* interdicted a smuggling vessel with over 130 Haitians onboard, *Resolute* sent security watchstanders and medical personnel over to help their crew process, care for, and eventually repatriate them back into Haiti.

Following emergent tasking to increase presence in key areas along our southern maritime border and approaches, *Resolute* was directed to go to Guantanamo Bay, Cuba and assist a Joint Task Force with building out facilities on the naval base. As the first and only Coast Guard asset on scene, we quickly integrated into a team of volunteers that included Navy Construction Battalion "Seabees," Army South, Marine Corps, crew from the USS *St. Louis*, and others from across the interagency. Over the course of four days, we assisted with building out camp capacity, including staging over 40 tons of material, assembling 350 cots, and constructing 76 tents, which would have provided housing for over 1,000 deployed service members.

While underway, the crew focused heavily on training and readiness, conducting boat operations, pursuit training with Customs & Border Protection, several landings with a helicopter out of Air Station Miami, and building bench depth in key underway qualifications including Officer of the Deck, Engineer of the Watch, Cutter Boat Coxswain, and Security Watchstander. The crew also conducted nearly 70 drills that honed their proficiency in damage control and response to emergencies.

In between underway periods, the crew enjoyed port calls in San Juan and Key West. We also had a unique opportunity to anchor near Fort Jefferson in the Dry Tortugas, where the crew explored the old fort, relaxed on the beaches, and fished the crystal-clear waters. While operating along the Florida Keys, we also had an opportunity to meet up with the SS *United States*, a historic ocean liner built in 1950 that was being towed to her new home as an artificial reef off Destin, FL. It made for an amazing photo op!

As always, thank you for lending your sons, daughters, husbands, wives, friends, and family to this Service, this ship, and this mission. Serving at sea is never easy, but it is very rewarding work – and I'm honored to be sharing it with Team *Resolute*. Until next time!

Whether through a team building experience or simply standing the watch, the crew's professionalism and dedication to the mission were truly exceptional. As we return home, we want to express our gratitude for your continued support during another successful patrol.


Pepper Ball Training!

Resolute's weapons division ran multiple Law Enforcement (LE) crew members through pepper ball training.




"Set the Small Boat Detail!"

Resolute's crew conducted multiple small boat evolutions for passenger transfers and trainings to get crew members qualified!














Transiting through the Canal de la Tortue

50 Haitian sailboats.












